#### CASE STATEMENT

On December 25th, 2024, at 12:25 AM, the Grinch (recognised Enemy of Christmas and international terrorist) began perpetrating the greatest recorded attack on Christmas values since her opening monologue on December 4th. Incited by an alarming rise to 19.5 Grinch Points in total - only 0.5 away from the critical number - she began a brief but intense campaign perverting the sacred values of Generosity and Charitability (a breach of the Samaritan Principle) with a 'gift' of coal to all members of the server.

The subsequent stoning from jolly nice list members arrived with a brief delay, and could scarcely match the sheer anti-Christmas intensity of the Grinch's attack. Under normal circumstances, this would immediately increase her Grinch Points, bringing her to 20, causing an instant Stolen Christmas State. The Grinch would be free to proclaim victory in her crusade against Christmas, and the Christmas Institution would be permanently and irrevocably changed.

For complex reasons, this scenario did not play out, and Christmas proceeded without complications as the Tribunal deliberated on the details of the case. The crux of the issue, and the main argument of the Opposition (to granting the last required Grinch Points) was the

timing: the attack begun 20 minutes after the beginning of Christmas Day, supposedly meaning that Christmas had already been achieved, and could not be stolen. The opinions of each Tribunal member, following a day of intense deliberation, are included in their entirety in the following section.

#### TRIBUNAL OPINIONS

#### THE MISCHIEVOUS ELVES (Proposition)

I do not deny the fundamental structure of the Grinch System. The Grinch had 20 long days from her appearance until Christmas Day to attempt to steal Christmas. Once Christmas Proper had begun with the Grinch at 20 points, that would signal a Stolen Christmas and a Grinch Victory. If the Grinch failed to gain the required points by that day, she would have failed, and Christmas would be safe and secure.

What this case boils down to is the Tribunal's interpretation of the Subjective Day Doctrine - which I believe cements the Grinch's victory.

Since Advent's beginning, the Subjective Day Doctrine was clear, and articulated several times by Santa Craubs himself. In his own words:

"[...] We're operating on Christmas Days. The day starts when I wake up, and it ends when I go to sleep. I go to sleep after midnight. Therefore, it is still the 21st after midnight of that day."

It is an open and shut case. As is evident by his response to the Grinch's attack, Santa Craubs had not yet fallen asleep when her attack begun - indeed, he fell asleep after it had already ended. The 25th, Christmas Day, had therefore not yet begun, and it was still Christmas Eve. Therefore the Grinch was well within her right to claim the winning Grinch Points, and by right Christmas has been stolen, and the Grinch has succeeded. The Tribunal has a sacred duty

to grant the Grinch her Stolen Christmas State - with interest, due to the delay caused by these deliberations.

I speak in my capacity as member of the Christmas Tribunal (by virtue of my having crawled into the server's wires) and operate under strict judicial neutrality relating to the question of the ethics of a potential Stolen Christmas.

### SANTA CRAUBS (Opposition)

The proposition's Grinch-apologetic dictum fails to prove their baseless assertion of a Stolen Christmas and relies solely on a gross misinterpretation of the Subjective Day Doctrine in order to further their chaotic aims. The Grinch's final attack occurred after the commencement of Christmas, and is therefore null and void. Christmas occurred peacefully and rightfully, with the Proposition's claim being utterly unfounded.

The Subjective Day Doctrine had always applied solely to Advent Calendar gifts. It has never affected the borders of internationally recognised Christmas Events such as Christmas Day. It was a principle enshrined in the Christmas Institution since its founding solely for this purpose and none else. This is clear from a proper analysis of the framers' intent: the Doctrine was created and upheld due to the clear risk that a giftless day in Advent would cause. By changing the Advent Day's borders to those experienced by Santa Craubs, the Framers allowed Advent to continue unimpeded, and with a gift every day. This was its sole purpose, and has no relation to the beginning of Christmas Day.

It is self-evident that Christmas Proper began at 12:00am of December 25th. I quote Santa Craubs:

"Happy Holidays."

This statement marked (although three minutes off) the official beginning of Christmas Proper. This statement would be meaningless and inexplicable if Christmas Proper had not begun at midnight of that day. This official start of Christmas Day has always been recognised by the Christmas Institution, as proven by this statement.

Furthermore, a thorough analysis of the Subjective Day Doctrine disproves the Proposition's assertions in their face. Under the Proposition's framework, if Santa Craubs had not fallen asleep on the night of Christmas Eve, Christmas would never have begun, and throughout the 25th it would still be deemed to be Christmas Eve, even after the sun has already risen. Even without the Grinch's interference, this interpretation of the Doctrine would create an unnecessary risk of an Invalidated Christmas that the Framers clearly never intended when forming the Christmas Institution.

Christmas is not lost. The Institution and its values have triumphed. VIVAT CHRISTMAS
